<p><u>RISK PRIORITY</u></p> <p>HIGH</p> <p>MED</p> <p>LOW</p>	<p>HIGH: Accident likely - with possibility of causing serious injury or loss</p> <p>MEDIUM: Possibility of accident - causing minor injury or loss</p> <p>LOW: Accident unlikely - with control measures in place</p>

5 steps to Risk Assessment

1. Identify the Hazards
2. Decide who may be harmed
3. Identify the control measure already in place
4. Evaluate the remaining risk (High, Medium, Low)
5. Identify any further action needed to reduce the risk to the lowest *reasonably practicable* level

Pupil / parent / visitor becomes aggressive	Staff/pupils/vistors/contractors	<p>Staff to be aware of puils possible triggers No new member of staff to be left alone with possible aggressive pupil / parent / visitor Staff trained in de-escalation techniques where possible. Other affected people removed. Staff never to be left alone with aggressive Pupil / parent / visitor Routes out of room/meeting place kept free All verbal aggression and psycial aggression logged on the PRIME system.</p>	L	
Pupil / parent / visitor becomes violent	Staff/pupils/vistors/contractors	<p>Staff to be aware of possible triggers. No new member of staff to be left alone with possible aggressive pupil / parent / visitor. Staff trained in de-escalation techniques where possible Staff never to be left alone with violent Pupil / parent / visitor Other affected people removed. Staff to distance themselves immediately. Routes out of room/meeting place kept free. Police called imedately. All verbal aggression and psycial aggression logged on the PRIME system</p>	L	
Pupil / parent / visitor becomes violent or aggressive with lone worker.	Lone worker/staff/pupils/visitors	<p>Lone worker to immediately leave the situation. If the lone worker is unable to leave, call for assistance.</p>	L	
Physical injury	Lone worker/staff/pupils/visitors	<p>Injured party to receive medical attention immediately. Taken to hospital if needed. Report incident on PRIME.</p>	L	

Stress/wellbeing issues after a violent and/or aggressive event.	Lone worker/staff/pupils/visitors	Support to be given to all those affected. Counseling offered.	L
